2. Verification of Conflict of Interest

The issue of the Student coordinator-The chosen candidate wanted to work on a contract basis, the second one in line refused the employment-the third person in line is currently working for Social Services-position is delayed-the Board of Education is requesting to meet with the Director of Human Resources when she comes back from vacation.

The Director General will get in touch with Listuguj to find out how they are deducting from individuals who are working and to pay the band back through any funds from that they will receive from the Band, welfare, estuary dollars, work.

The issue of the estuary dollars is up for negotiations next year.

There was a committee a few years ago before the estuary dollars were given to households and fishermen, the committee has been abolished since then, Some council would like to have a list of individuals to form the estuary committee, members will be asked if they are interested joining the committee. There will be a public meeting on the 26th, 2016 to address housing and estuary dollars.

Housing committee-a board member was replaced based on rumours that he was making promises to individuals to give them housing units. The member has been replaced, however he can appeal the decision to be reinstated.

When CMHC comes to make their presentation will be asked how to go about individuals to get insurance for their contents.
