A draft letter was prepared by Chief John Martin to Marie-José Thomas to discuss the Estuary. A meeting that was scheduled on January 24<sup>th</sup>, 2020 was cancelled by the Quebec Government and a new date has not yet been determined. Council agrees with the draft letter, the letter will be signed by Chief John Martin and mailed out.

- Participated in a CCOE meeting last week, the Quebec region will be receiving 6.5
  million dollars; for Post-Secondary partnerships programs there was a split decision
  on both meetings.
- The video camera was removed in the finance department. There is one at the Galgoasiet bingo hall, due to damages in the past, a camera was put in place. The Maintenance Supervisor has access to the cameras; departments have to make the request to the Maintenance Supervisor to have access to the cameras. Health has two camera systems in place.

#### 11.1.1Wejgwapniag Closure for 2019-2020 school year

Chief and Council adopts option 1. With modifications; Keep Wejgwapniag closed to students for the remainder of the 2019-2020 school year.

Students will not enter the school for the remainder of the school year 2019-2020, but will continue to receive online and distance learning until June 12, 2020 and have the teachers

prepare for the next school year from June  $15^{th}$  to June  $26^{th}$ , 2020. All buildings remain subject to COVID-19 measures.
